

## **Reagent Water Specification Testing Results**

For the month of: June 2010 (Lot#10152 – 10181)

Listed below are the testing results for the reagent water used in the manufacture of products at Hardy Diagnostics. The data was found to meet or exceed the following test specifications which are also outlined in *Standard Methods for the Examination of Water and Wastewater*<sup>4</sup>.
